

SUMMARY OF BENEFITS

WINDSHIELD REPLACEMENT

Windshield replacement is offered only in the event of minor chips and cracks caused by propelled rocks or other propelled road debris.

PAINT-LESS DENT REPAIR

(PDR) is a process that uses specialized hand tools to treat minor dents or dings, less than 4-inches in length or diameter. Does not apply to scratches, nicks or paint discoloration.

INTERIOR REPAIR

Protection against minor interior (rips, scratches, cracks, stains, or tears -less than 3-inches) damage to your vehicle up to \$250 per incident.

CLAIM PROCEDURES

You MUST obtain authorization prior to replacement of any tire or auto part. To qualify for benefits all claims must be reported as soon as reasonably possible.

IF YOU NEED TO MAKE A CLAIM:

- 1 NOTIFY.** Call us at **877-674-6123** within 30–60 days of protected event.
- 2 VERIFY.** Document protected event by keeping any materials or information related to your claim.
- 3 DON'T DELAY.** It takes time to process your request for benefits. You are still responsible for your monthly payment while your claim is in process.

Once benefits begin, you are responsible for any difference between the minimum payment due on the loan and the amount that is canceled.

COVERED EMERGENCIES



Towing Assistance. When towing is necessary, the covered vehicle will be towed to the nearest repair facility to the disablement site. You will be responsible for the extra cost of towing should the distance exceed the coverage limitation from the disablement site.



Flat Tire Assistance. Service consists of the removal of the covered vehicle's flat tire and its replacement with the spare tire. Towing Assistance will be provided, if necessary.



Fuel, Oil, Fluid, & Water Delivery Service. An emergency supply of fuel, oil, fluid, and water will be delivered if the covered vehicle is in immediate need. You must pay for the fuel or other fluid when it is delivered.



Lock-Out Assistance. If your keys are locked inside the covered vehicle, assistance will be provided to gain entry into the vehicle.



Battery Assistance. If battery failure occurs, a jump start will be provided to start your covered vehicle. Towing Assistance will be provided, if necessary.



Collision Assistance. If your covered vehicle is involved in an accident or collision, towing assistance will be provided when needed to direct the vehicle to the nearest repair facility up to twenty-five (25) miles from the disablement site. You are responsible for the extra cost of towing.

IMPORTANT:

Please be with your covered vehicle when the service provider arrives, unless it is unsafe to remain with the vehicle, as they cannot service an unattended vehicle.

KEY/REMOTE REPLACEMENT

If your key/remote is lost, stolen or destroyed it will be replaced. For the owner's safety, all reported keys/remotes must be deprogrammed prior to replacement.



UNSERVICEABLE

The tire(s) has been punctured or otherwise damaged to the extent that it is unsafe or that the wheel will no longer hold a seal with its tire.

ROAD HAZARD

A condition on a public roadway, which should not exist there, such as potholes, nails, glass or other road debris.

YOUR RESPONSIBILITIES

You must maintain proper air pressure in all covered tires. Tires should be checked monthly for proper pressure, signs of dry rot, improper wear, and tread depth less than 3/32".

Any faults that cannot be corrected require replacement for the safety of the vehicle occupants. Replaced tires are covered for the time remaining on the Agreement.

TIRE AND WHEEL ROAD HAZARD PROTECTION

Provides for the repair or replacement of the vehicle's tires and wheels deemed unserviceable due to a Road Hazard.

Included:

- Flat Tires
- Wheels
- Rims
- Tire Replacement
- Mounting and Balancing

Tire and/or wheel damage that is cosmetic in nature and that does not render the tire and/or wheel unserviceable is specifically excluded.
