

Mobile Banking Contest - Official Rules

1. This contest is open to members of a participating credit union who are 18 years or older and legal residents of the United States at time of entry (excluding, without limitation, such residents if located in Puerto Rico and other U.S. Territories). Employees of Notre Dame FCU and their immediate family members are not eligible.
2. Eligible members of participating credit unions may enter the contest by:
 - a. Accessing their Notre Dame FCU Account via their mobile app.
 - b. Printing their name, credit union, address, telephone number and age on a post card or piece of paper and mailing it to: CU*Answers, Attn: Marketing Contest, 6000 28th St. SE, Grand Rapids, MI 49546.
3. All entries received from April 1 - May 31, 2019 will qualify and be entered into the drawing. All entries become the property of Notre Dame FCU, will not be returned, and are subject to verification. Each time an eligible member accesses their Notre Dame FCU account by logging in to their mobile app or mails a post card as described above during the contest period they will be entered in the contest allowing for multiple entries.
4. The winner will be selected by a random drawing to be held on June 12, 2019 from qualified entries received. The drawing will be held at Notre Dame FCU at 1828 Moreau Drive, Notre Dame IN, by Notre Dame FCU staff members. The winner will be notified by email or by telephone. The number of qualified entries will determine the odds of winning. If the winner cannot be contacted or does not respond in 45 days, the winner will be disqualified and a substitute winner will be randomly selected from the remaining entries.
